## **Description of necessary first aid measures**

Eye contact

# Section 5. Fire-fighting measures

# Specific hazards arising from the chemical

: Highly flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. The vapor/gas is heavier than air and will spread along the ground. # Section 7. Handling and storage

### **Precautions for safe handling**

### **Protective measures**

Put on appropriate personal protective equipment (see Section 8).
